## Camping Code

McCormack Park is private property. Please respect the owners of the land and be considerate of other campers by following the rules and conditions outlined below.

1. Merrijig Rodeo committee reserves the right to:

- *refuse entry, or terminate occupancy, at any time to any person without any redress or reason*
- *evict any person or persons and remove their property from the camp site*
- *require an occupant at any time to move to another site at the Merrijig Rodeo Committee discretion.*

2. Merrijig Rodeo Committee accepts no responsibility for caravans, camps, motorhomes or vehicles and their contents whilst they remain at McCormack Park.

3. For the safety of all campers, vehicles must be secured using the chocks provided by the camping marshals.

4. Campers are reminded that 0.05 alcohol limits for driving apply within the camping area.

5. No vehicle is to be moved between the hours of 8pm on Saturday night and 6am on Sunday morning.

If you need to move your vehicle during the above hours, please contact security for assistance.

6. Camp sites must be vacated by 10am Sunday morning.

7. Camping Fees may be [pre-paid online](#) or on arrival at the gate.

8. All occupants have the right to a good nights' sleep. No undue noise after 10pm.

9. Campers must keep their site clean and tidy. Rubbish must be deposited in the bins provided.

10. Illegal drugs, offensive language and excessive use of alcohol will not be tolerated.

11. No fires are permitted in the camping area. Generators may be used between the hours of 8am and 10pm.

12. Dogs are permitted in the camping area, however they must be restrained and under the strict control of the owner at all times. All droppings are to be collected and disposed of by owners. Dogs are not permitted in the rodeo grounds under any circumstances.

13. The wild kangaroo and wombats that graze at McCormack Park are an evening tourist attraction and should not be disturbed in any way.
